# 英國倫敦聖三一學院音樂考試－報名須知

## Trinity Music Examinations - Enrolment Information

**Please read the syllabuses carefully before enrolling.** 請於報名前仔細閱讀考試章程。

凡報名參與英國倫敦聖三一學院音樂考試之考生，均被視作接受刊於“考試章程”內之規則及以下條款：Candidates of Trinity Music Examinations are assumed to agree and abide by the regulations published in “Examination Syllabuses” and the following conditions:

### 一般報名須知 General Enrolment Information

- 聖三一(香港)音樂中心(本中心)有權對考試日期及截止報名日期作出更改。Trinity Hong Kong Music Centre (THKMC) reserves the right to change the above examination dates and enrolment dates.
- 考試報名必須於截止日期前遞交。本中心有權拒絕任何於截止日期後遞交之報名，以及對逾期報名徵收附加費用。Entries must be submitted before enrolment closing date. THKMC reserves the right to refuse any entries submitted after the closing date and surcharges will be applied to all late entries.
- 報名表格上之考生姓名與出席考試之考生必須相符，任何情況下考生不能被更換 / 替代。聖三一音樂考試考官及考試助理有權要求考生出示身份證明文件。The named candidates on the entry form must be the candidates attending the examination; under no circumstance may substitute candidates replace the originally entered candidates. Trinity examiners and exam stewards have the right to request for the proof of identity of candidates.

Administration fee will be charged for any request of examination re-arrangement. There is no guarantee that applications will be successful, due to various constrains.
